NATIONAL AFFAIRS

1. Government of India Revised Target to Add 97 GW Coal and Lignite-Based Power Capacity by FY35.



In August 2025, Union Minister of State for Power, Shripad Yesso Naik, in a written reply in the Rajya Sabha (Upper House of Parliament), announced that the Government of India (GoI) has revised its target to add an additional 97 Giga Watt (GW) of coal and lignite-based power generation capacity by Financial Year 2034-35 (FY35), up from the earlier projection of 90 GW by FY32.

- The revised target aims to achieve a total of 307 GW of coal and lignite-based thermal power installed capacity by FY35. This revision reflects Gol's updated power demand projections and the need to balance energy security with clean energy expansion.
- This coal capacity addition is aligned with India's larger energy roadmap that seeks to achieve 500 GW of Renewable Energy (RE) capacity by 2030 and the Net Zero emissions target by 2070. Thermal power expansion will serve as a stabilizing source while RE capacity scales up.
- Earlier, Gol projected that about 283 GW of coal and lignite-based capacity would be

required by FY32. In November 2023, the Ministry of Power (MoP) proposed setting up a minimum of 80 GW of additional coal-based thermal capacity by FY32, which has now been revised to 97 GW by FY35.

Key Points:-

- (i) As of June 2025, India's total installed electricity generation capacity stands at 485 GW, comprising coal, lignite, hydro, gas, nuclear, and renewables. Thermal power still contributes the largest share, making it critical for India's base-load demand fulfillment
- (ii) According to the National Electricity Plan (NEP) 2023 (Generation), India's total installed capacity is expected to reach 874 GW by FY32. This expansion includes both renewable and thermal energy, reflecting India's "energy mix" strategy for sustainable growth.
- 2. Union Minister Jyotiraditya Scindia Announced Nationwide Rollout of IT 2.0 Advanced Postal Technology (APT).



In August 2025, Union Minister of Communications Jyotiraditya Madhavrao (M.) Scindia officially announced the nationwide rollout of Advanced Postal Technology (APT)





under India Post. This Rs.5,800 crore project is part of India's Information Technology (IT) 2.0 program to modernize, digitalize, and enhance customer-centric postal services.

- The IT 2.0 APT program is a Rs.5,800 crore investment under the Ministry of Communications (MoC), designed to build upon Project IT 1.0 by enabling faster, smarter, and more efficient postal operations across India.
- The system has been developed indigenously by the Centre for Excellence in Postal Technology (CEPT), operating under the Department of Posts (DoP), MoC. It reflects India's growing emphasis on technological self-reliance in the postal sector.

Key Points:-

- (i) APT is hosted on the MeghRaj 2.0 cloud platform of the Government of India (Gol) and supported by Bharat Sanchar Nigam Limited (BSNL), ensuring secure, scalable, and reliable digital infrastructure for nationwide operations.
- (ii) Key features of IT 2.0 include a single unified user interface, QR code-based payments, One Time Password (OTP)-enabled delivery, and a 10-digit alphanumeric Digital Postal Index Number (DIGINP) to enhance accuracy, security, and transparency in postal transactions.
- (iii) The rollout of IT 2.0–APT is being executed in phases across 23 postal circles, beginning with a pilot in Karnataka (May–June 2025) and completed nationwide by August 4, 2025, covering over 1.70 lakh post offices in India.
- 3. IIT Madras and FedEx Launch SMART Centre for AI-Driven Logistics Solutions in Chennai.



In August 2025, the Indian Institute of Technology Madras (IIT-M) in collaboration with Federal Express Corporation (FedEx), a leading American transportation company, inaugurated the FedEx SMART Centre (Supply Chain Modelling, Algorithms, Research, and Technology Centre) at the IIT-M campus in Chennai, Tamil Nadu. This initiative is designed to advance Artificial Intelligence (AI)-driven, sustainable logistics solutions

- The FedEx SMART Centre is backed by a 5-year funding support of USD 5 million (approximately Rs 44 crore) from FedEx. This financial assistance will enable IIT Madras researchers and students to collaborate with industry experts to create advanced technological solutions for logistics and supply chain optimization.
- The core function of the centre is to integrate advanced digital tools, algorithm-based research, and industry knowledge to design logistics networks that are flexible, resilient, and environmentally sustainable.
- It will focus on minimizing carbon footprints while enhancing efficiency in supply chain operations across sectors.

Key Points:-


(i) The key research areas of the SMART





Centre include development of carbonneutral operations, Al-driven predictive analytics for logistics, Electric Vehicle (EV) infrastructure integration, autonomous delivery systems, and worker safety systems powered by Al. These areas align with goals India's larger of sustainable development technological and advancement.

- (ii) The establishment of this centre strengthens IIT Madras's position as a global leader in applied research and FedEx's innovation. With international expertise in logistics and IIT-M's academic excellence, the partnership is expected to transformative deliver solutions challenges in supply chains, particularly in the context of increasing demand for sustainable and digital-first logistics systems worldwide.
- (iii) By launching this centre, IIT Madras and FedEx aim to contribute towards building an ecosystem where technology, innovation, and sustainability work together to redefine the future of logistics in India and beyond.
- 4. NCERT Launches Educational Modules on Operation Sindoor for Classes 3–12.



In August 2025, the National Council of Educational Research and Training (NCERT) introduced two educational modules for Classes 3-12 to educate students about Operation Sindoor, India's strategic response to the Pahalgam terror attack. These modules highlight military success, advanced technology, and national security awareness.

- Operation Sindoor was launched in May 2025 as a response to the April 22, 2025, Pahalgam terrorist attack, which killed 26 tourists. It targeted terrorist camps in Pakistan and Pakistan-occupied Jammu and Kashmir (PoJK), coordinated by Lashkar-e-Taiba, and planned with intelligence from the Indian Armed Forces.
- NCERT created two modules: "Operation Sindoor A Saga of Valour" for Classes 3-8 using stories and activities to engage young learners, and "Operation Sindoor A Mission of Honour and Bravery" for Classes 9-12 with detailed analysis of strategy, execution, and operational outcomes.
- The modules highlight India's defense capabilities, including the S-400 air defense system neutralizing enemy drones and aircraft. Operation Sindoor demonstrated precision strikes on terrorist infrastructure while avoiding civilian casualties, reflecting India's advanced military technology and strategic planning.

Key Points:-

(i) Operation Sindoor served as a political message to Pakistan and the international community, showcasing India's strong stance against cross-border terrorism. It reinforced India's commitment to national security, strengthened diplomatic credibility, and highlighted proactive defense and counter-terrorism measures on a global stage.





- (ii) Aligned with the National Education Policy (NEP) 2020, these modules integrate real-world events into curricula, fostering critical thinking, national pride, and security awareness. Students learn India's geopolitical challenges, military ethics, and the importance of protecting national sovereignty through experiential learning and historical analysis.
- (iii) The modules received positive feedback from educators and policymakers for modernizing curricula and raising national awareness. While some political debates arose over content, NCERT plans future modules on other significant national events, aiming to deepen students' understanding of India's defense and geopolitical priorities.
- 5. Centre Approves Renaming Jalalabad to Parshurampuri in Uttar Pradesh, Honouring Lord Parshuram.



In August 2025, the Union Ministry of Home Affairs approved renaming Jalalabad town in Shahjahanpur district, Uttar Pradesh, to "Parshurampuri." The change honours Lord Parshuram, the sixth avatar of Lord Vishnu, and reflects the region's mythological significance as his believed birthplace.

- Local texts and religious traditions associate Jalalabad with the birthplace of Bhagwan Parshuram, a revered figure in Hindu mythology. Over centuries, pilgrimage and worship centres emerged around his ancient temple here, making the town a focal point for spiritual reverence and cultural heritage in the region.
- The name change has been long in the making
 — supported by public sentiment, local Hindu organisations, Jalalabad's Municipal Council, and multiple resolutions passed in 2018 and 2023.

 These were followed by formal recommendations from District Magistrate Dharmendra Pratap Singh in April 2025.
- Chief Minister Yogi Adityanath's administration swiftly endorsed the proposal. On June 27, 2025, the Uttar Pradesh Chief Secretary sent an official recommendation to the Centre. Minister of State Jitin Prasada also publicly lauded it, calling it a moment of pride for the community.

Key Points:-

- (i) Union Home Minister Amit Shah granted the nod after receiving the state's request and a recommendation from the Ministry of Science and Technology on August 14, 2025. The MoHA communicated its no-objection, prompting the state to proceed with the official Gazette notification in Hindi, English, and regional languages.
- (ii) With the renaming, local administration intends to enhance the temple precinct and surrounding infrastructure. Funds under the Chief Minister's Development Scheme and Amrit Sarovar Scheme have been allocated for beautification, pathway construction, and renovation of a 42-acre temple tank to boost religious tourism.
- (iii) The rechristening of Jalalabad to






Parshurampuri is expected to cement the town's identity rooted in indigenous spiritual legacy, reinforcing cultural pride historical continuity. Once the gazette notification is issued, the new name will be officially adopted across maps, government records, and signages, marking a symbolic shift away from its Mughal-era nomenclature.

INTERNATIONAL

1. India and Saudi Arabia Establish Joint Working Group to Strengthen Maritime Trade, Logistics, and Sustainable Infrastructure.



In August 2025, following a high-level virtual meeting between India's Union Minister of Ports, Shipping and Waterways, Sarbananda Sonowal, and Saudi Arabia's Minister of Transport and Logistic Services, Saleh bin Nasser Al-Jasser, both nations announced the creation of a Joint Working Group to enhance maritime cooperation in shipping and logistics.

• The Joint Working Group (JWG) on maritime cooperation was established to build on the Strategic Partnership Council's agenda, aiming to strengthen bilateral ties through focused policy dialogue and infrastructure collaboration in shipping and logistics sectors.

- This initiative followed a virtual high-level meeting between India's Minister Sarbananda Sonowal and Saudi Arabia's Minister Saleh bin Nasser Al-Jasser. During discussions, both sides emphasized historical economic ties and sociocultural convergence as foundations for deeper maritime engagement.
- Sarbananda Sonowal highlighted the launch of the new Jeddah–Mundra/Nhava Sheva shipping route by Saudi Arabia's Folk Maritime Services that promises reduced transit time and cost. He also proposed collaboration on India's MAITRI digital platform to facilitate seamless maritime trade.

Key Points:-

- (i) Bilateral trade between India and Saudi Arabia stood at approximately USD 42 billion in FY 2024–25. The maritime cooperation initiative aligns India's Maritime India Vision 2030 and Amrit Kaal Vision 2047 with Saudi Vision 2030, offering synergistic pathways in logistics, sustainability, and trade infrastructure.
- (ii) India invited Saudi investment into its maritime ecosystem through its Maritime Development Fund, with a corpus exceeding USD 3 billion. Major projects like Vadhavan Port (Maharashtra) and the Outer Harbour Project at VO Chidambaranar Port (Tamil Nadu) were presented as prime investment opportunities.
- (iii) The collaboration seeks to build joint ventures in green hydrogen hub ports, digitalized port operations, and sustainable shipping solutions. With India's trillion-dollar maritime roadmap, the partnership emphasizes investments in future-ready, environmentally conscious maritime infrastructure.





BANKING & FINANCE

1. EXIM Bank Signs USD 40 Million Credit Line Agreement with ECOWAS Bank for Investment and Development.



In August 2025, the Export-Import Bank of India (EXIM Bank) signed a USD 40 million commercial credit line agreement with the **ECOWAS** Bank for Investment Development (EBID), the financial institution of the Economic Community of West African States (ECOWAS). This agreement is aimed India-Africa strengthening economic financing infrastructure cooperation and projects in West Africa.

- The agreement was signed between Dr. George Agyekum Donkor, President and Chairman of the Board of Directors (BoD) of EBID, and Mr. Ashok Kumar Vartia, Chief Executive of the EXIM Bank's London Branch, United Kingdom (UK). The deal reflects India's increasing engagement with African development finance institutions.
- The primary objective of this agreement is to provide funding for developmental and infrastructure projects in ECOWAS member states, with significant participation from Indian companies. Areas expected to benefit include

renewable energy, healthcare, transport, and industrial capacity building.

• This credit line is strategically important as it will boost South-South Cooperation, opening new trade opportunities for Indian exporters while supporting African countries in achieving sustainable growth. It also reflects India's broader policy of economic diplomacy in Africa.

Key Points:-

- (i) India's partnership with EBID dates back to 2006, when the first line of credit was extended. Over the years, EXIM Bank has provided six different credit facilities to EBID, with a cumulative value of USD 1.14 billion, enabling procurement of Indian goods, machinery, and services by African nations.
- (ii) The current agreement further strengthens India's presence in Africa and builds on the foundation of long-standing bilateral ties. It is expected to enhance mutual trust, expand India's export footprint, and help ECOWAS nations implement critical development projects with reliable financing from India.
- 2. Punjab National Bank (PNB) Becomes 1st PSB in India to Migrate to '.bank.in' Domain.







In August 2025, Punjab National Bank (PNB), India's 2nd largest Public Sector Bank (PSB), became the first Indian PSB to migrate its corporate website to the secure '.bank.in' domain. This step was taken in line with the Reserve Bank of India's (RBI) April 2025 circular to strengthen cybersecurity in digital banking.

- Punjab National Bank (PNB) has migrated its corporate website from the earlier www.pnb.bank.co.in to the new https://pnb.bank.in domain, making it the first Indian PSB to adopt this digital shift. This move marks an important milestone in India's efforts to combat digital banking frauds.
- The initiative follows the Reserve Bank of India (RBI) directive that mandated Indian banks to transition their corporate websites to the new secure '.bank.in' domain. RBI issued this notification in April 2025 to create a more secure digital ecosystem for financial institutions.

Key Points:-

- (i) The exclusive registrar for the '.bank.in' domain is the Institute for Development and Research in Banking Technology (IDRBT), which will oversee domain registrations, compliance, and safety measures. This ensures that only authorized Indian banks can use the domain.
- (ii) The primary aim of this domain migration is to strengthen cybersecurity, reduce risks of phishing attacks, and boost public confidence in digital banking. In addition, RBI is also planning to introduce '.fin.in' as a dedicated domain for non-bank financial entities, ensuring uniform security standards across the financial sector.

ECONOMY & BUSINESS

1. India's Marine Fish Production Reaches 44.95 Lakh Tonnes in 2023–24 and Backed by PMMSY & Aguaculture Growth.



In 2023–24, India's marine fish production rose impressively to 44.95 lakh tonnes, up from 34.43 lakh tonnes a decade earlier, reflecting sustained growth in ocean-based fisheries.

- From just 5.34 lakh tonnes in 1950–51, India's marine fish production has scale to 44.95 lakh tonnes in 2023–24, thanks to persistent investments, technological advancements, and improved fishing infrastructure.
- According to the EnviStats India 2025 report, marine fish production rose from 34.43 lakh tonnes in the baseline period to 44.95 lakh tonnes in 2023–24, underscoring the sector's upward trajectory and its growing contribution to national seafood supply.
- While marine capture fisheries have grown strongly, coastal aquaculture, especially shrimp farming, has driven export surges. Shrimp production alone climbed nearly 270% between 2013–14 and 2023–24, enhancing India's seafood export figures.

Key Points:-





- (i) India's extensive 8,118 km coastline and a 2.02 million sq km Exclusive Economic Zone (EEZ) hold an annual fisheries potential of 5.31 million metric tonnes. Thus, despite current achievements, there remains significant untapped potential in deep-sea and high-sea fishing to further boost marine output.
- (ii) Central government support particularly under schemes like the Pradhan Mantri Matsya Sampada Yojana (PMMSY) the **Fisheries** & Aquaculture and Infrastructure Development Fund (FIDF) fueled infrastructure development, enabling the fisheries sector to rise from 95.79 lakh tonnes in 2013-14 approximately 195 lakh tonnes in 2023-24. Marine fish production has also notably doubled over the last decade.
- 2. ICRA Projects India's Q1FY26 GDP Growth at 6.7%, Higher than RBI's 6.5% Forecast.



In August 2025, ICRA Limited (formerly Investment Information and Credit Rating Agency of India Limited) projected India's Gross Domestic Product (GDP) growth at 6.7% for Q1 of FY2025-26 (April–June 2025). The growth outlook is supported by higher government expenditure and robust export

performance. This projection is higher than the Reserve Bank of India (RBI)'s forecast of 6.5%, though lower than the 7.4% recorded in Q4FY25.

- ICRA has projected India's Gross Value Added (GVA) growth at 6.4% for Q1FY26, compared to 6.8% in Q4FY25. This indicates a slight moderation in economic activity despite strong fiscal push. The decline reflects slower expansion in some industrial and services segments compared with the previous quarter.
- The report highlighted a sharp rise in Capital Expenditure (CapEx) by the central government. Gross CapEx surged by 52% year-on-year (YoY) to ₹2.8 trillion in Q1FY26.
- This compares with a 33.4% growth in Q4FY25, and a 35% contraction in Q1FY25, showcasing a significant turnaround in government-led infrastructure spending.

Key Points:-

- (i) According to ICRA, the gap between GDP and GVA growth is projected at 30 basis points (bps) in Q1FY26, down from 62 bps in Q4FY25. A positive gap signals that net indirect taxes (taxes minus subsidies) are likely to continue supporting GDP growth over GVA.
- (ii) The agency concluded that India's Q1FY26 economic momentum will be driven by strong export demand and government spending, but overall growth is expected to remain lower than the 7%+ levels achieved in the previous quarter.
- (iii) This outlook provides a balanced yet cautious assessment of India's short-term economic trajectory.





MOUs and Agreement

1. Centum Electronics Signs MoU with BEL for Advanced Defence Electronics Projects.



In August 2025, Bengaluru-based Centum Electronics Limited (Ltd) signed a Memorandum of Understanding (MoU) with Bharat Electronics Limited (BEL), a Defence Public Sector Undertaking (PSU) under the Ministry of Defence, to collaborate on advanced defence electronics projects aimed at boosting India's defence capabilities.

- The MoU was formally signed at BEL's Corporate Office between Suresh Kumar K V, Director (Marketing) of BEL, and Apparao V Mallavarapu, Chairman and Managing Director (CMD) of Centum Electronics Ltd. The agreement is expected to foster strong industrial cooperation in the defence technology sector.
- The signing ceremony was witnessed by key dignitaries including Manoj Jain, CMD of BEL, and Dr. Vinod Chippalkatti, President of Centum Electronics Ltd, highlighting the strategic importance of the partnership for both organisations.
- The cooperation will primarily focus on the development of advanced Electronic Warfare (EW) systems, next-generation radar technologies, and secure communication

solutions to strengthen India's Armed Forces. These systems are critical for modernising India's defence infrastructure and enhancing national security.

Key Points:-

- (i) The signing ceremony was witnessed by key dignitaries including Manoj Jain, CMD of BEL, and Dr. Vinod Chippalkatti, President of Centum Electronics Ltd, highlighting the strategic importance of the partnership for both organisations.
- (ii) By joining forces, Centum Electronics and BEL aim to accelerate innovation in defence electronics, aligning with the Government of India's vision of Atmanirbhar Bharat (self-reliant India). This partnership is expected to enhance indigenous capabilities and reduce reliance on foreign technologies in the sensitive domain of defence systems.
- (iii) The MoU reflects a broader strategy by the Ministry of Defence to encourage collaborations between public and private enterprises for cutting-edge solutions, ensuring India's preparedness in modern warfare scenarios and securing technological defence superiority in operations.

App and Web Portal

1. Delhi Government Approves Launch of 'Delhi Mitra' App as Unified Public Grievance Redressal System.







In August 2025, the Delhi Cabinet led by Chief Minister (CM) Rekha Gupta approved the launch of the 'Delhi Mitra' application, an integrated Public Grievance Redressal System (PGRS) designed to provide citizens with a single-window platform for complaint resolution.

- The 'Delhi Mitra' app will serve as a one-stop platform for grievances linked to multiple authorities, including the Delhi Government departments, Delhi Police, Municipal Corporations (MCs), and the Delhi Cantonment Board. This integration eliminates duplication of systems and ensures faster grievance processing for citizens.
- Residents of Delhi will be able to register their complaints through four channels: a dedicated web portal, the mobile app, WhatsApp services, and a call centre facility
- Additionally, handwritten complaints submitted at government offices will be scanned, digitized, and uploaded to the system, ensuring inclusivity for citizens who prefer offline submissions.

Key Points:-

(i) To strengthen accountability, the government will designate nodal officers in every department to monitor grievances and accelerate resolution. Public grievance officers will also organize weekly public meetings with citizens every Wednesday, creating a direct channel of dialogue between the administration and the public.

(ii) The launch of this digital-first PGRS highlights the Delhi Government's focus on transparency, efficiency, and citizen-centric governance. By integrating multiple agencies into one platform, the initiative is expected to significantly reduce delays, improve monitoring, and create a responsive government service delivery mechanism.

IMPORTANT DAYS

1. World Entrepreneurs' Day 2025 Celebrated annually on August 21.



On August 21, 2025, the world celebrates World Entrepreneurs' Day, a dedicated occasion recognizing the vision, risk-taking, and transformative impact of entrepreneurs worldwide. Established to honor bravery, innovation, and economic contributions, the day aims to inspire future changemakers.

• Celebrated annually on August 21, the date coincides with the birthday of NASA flight director Gene Kranz—symbolizing visionary leadership. It underscores entrepreneurship's





role in building economies, generating jobs, and inspiring social progress.

- World Entrepreneurs' Day spotlights the and determination courage, creativity, founders across industries. It encourages broader awareness of entrepreneurship's importance and motivates individuals to pursue business their dreams. fostering entrepreneurial mindset for future generations.
- Entrepreneurs are key drivers of innovation and economic growth. They create jobs, introduce disruptive technologies, and help economies thrive. In fast-growing markets, startups and small businesses now form the backbone of regional GDP and innovation ecosystems.

Key Points:-

- (i) This year's focus (even while not officially announced) leans toward sustainability, inclusivity, and digital transformation. It highlights impact-driven entrepreneurship—ventures that prioritize social and environmental value alongside profit.
- (ii) Observances include global and local startup events like hackathons, pitch networking sessions. workshops, and summits. From universities to business hubs. to activities aim elevate entrepreneurship through mentorship, education, and public recognition trailblazers
- 2. World Senior Citizens' Day is observed globally on August 21.



World Senior Citizens' Day is observed globally on August 21 each year to recognize the invaluable contributions of older persons and raise awareness about the challenges they face. First proclaimed by U.S. President Ronald Reagan in 1988, it was later adopted internationally by the United Nations.

- President Ronald Reagan issued Proclamation 5847 on August 19, 1988, establishing August 21 as National Senior Citizens Day in the USA. The day was later recognized by the UN General Assembly in December 1990 and marked globally from 1991.
- The observance aims to highlight age-related issues such as declining health, elder abuse, and social exclusion. It emphasizes promoting the dignity of older citizens while celebrating their lifelong contributions to families, communities, and nations.
- While World Senior Citizens' Day (August 21) derives from U.S. origins and has international acknowledgment, the UN also observes the International Day of Older Persons on October 1, established by UN Resolution 45/106 in 1990.

Key Points:-

(i) According to the UN, the population of older persons is rapidly increasing worldwide. By 2050, the global count of





senior citizens is projected to exceed 1.5 billion, with two-thirds residing in developing countries—highlighting urgent needs for inclusive policies.

(ii) Communities observe the day through events like award ceremonies, social gatherings, local awareness drives, and health-care campaigns. Individuals also take opportunities to spend quality time with elders, volunteer at senior homes, and advocate for improved services and respect.

OBITUARY

1. Frank Caprio, 'Nicest Judge in the World' of Caught in Providence, Dies at 88.



Judge Frank Caprio, affectionately known as the "Nicest Judge in the World" and star of the viral courtroom series Caught in Providence, passed away on August 20, 2025, at the age of 88 after a prolonged battle with pancreatic cancer.

• Serving nearly four decades as Chief Judge of the Providence Municipal Court from 1985 to 2023, Caprio gained global admiration for presiding over minor offense cases with empathy, fairness, and a folksy sense of humor that emphasized understanding over punishment. • His courtroom became a cultural phenomenon via the TV series Caught in Providence. Launched locally in 2000 and syndicated from 2018, the show — celebrated for heartwarming rulings and Caprio's humane approach — earned several Daytime Emmy nominations and garnered billions of views online.

Key Points:-

- (i) Just hours before his passing, Judge Frank Caprio posted a deeply moving video on Instagram from his hospital bed, asking followers to remember him in their prayers a testament to his humility and faith. Tributes poured in from fans and public officials alike, with Rhode Island Governor Dan McKee ordering flags at half-staff in honor of Frank Caprio.
- (ii) Caprio's legacy extends far beyond his legal rulings. Beloved for his warmth, humility, and unwavering belief in the goodness of people, he touched millions through both his judicial work and as a viral internet figure. His death marked the end of a uniquely compassionate career.
